I was unable to leave a voicemail message on this number. I called the new number provided 862-276-5685 and the phone call went unanswered. The voicemail box was full, and I was unable to leave a voicemail message.  An internet search did not yield any results of a camp being conducted by the name Play Learn & Grow Before and Aftercare at the above address, although there was a sign for the camp outside the building.  A youth camp inspection was not conducted.
